- RG advised there is not much happening on site currently. The project has a severe handicap
  in that the DA consent specifies that there can be no material processing on site all
  processing must be done off site.
- We are planning to apply to modify the consent to allow on site processing
- Using the new innovative CDE closed loop on site processing system similar to the new processing plant recently installed at the Walkers quarry on the highway at Wallerawang
- TP outlined in dot points the process
  - o CDE process is new and innovative
  - Technology did not exist 20 years ago when project was proposed
  - o This process does not require tailings dams
  - o 90% water reuse
  - All enclosed in concrete bund
  - Fully closed loop
- LS asked about the life of the project specified in the DA consent and about community consultation during the modification process
- SL asked about the rehabilitation of the site
- RG confirmed that we had a detailed rehab plan
